The institution functioning is as per professional code of prescribed /suggested by statutory bodies/ regulatory authorities for different professions

Bethuadahari College is an affiliated college and it is affiliated to the University of Kalyani. As an affiliated college it is bound to comply with the statutory provisions of the Statute of the University of Kalyani.

As per Statute of the University of Kalyani, the Governing Body is the apex body in running an affiliated college. All the decisions are to be taken by the Governing Body. Appointment, suspension, promotion, pension all service related matters are executed by the Governing Body following the rules and regulations made by the appropriate authority.

As it is a Grant-in-aid College, the Government of West Bengal pays for its salary, allowances and other grants, the College is bound to obey the directions and rules and regulations of the Government applicable to it. The Department of Higher Education, Science, Technology and Biotechnology, Government of West Bengal and its Directorate of Higher Education control and monitor the service conditions of the regular as well as part time staff of the College.

As Bethuadahari College is recognized by the UGC and it is included under section 2b and 12F of the UGC Act, it is eligible to get financial grants of the UGC.

Bethuadahari College being a higher educational institution of West Bengal, it is under jurisdiction of the West Bengal Higher Education Council, Government of West Bengal. The guidelines provided by the Council are also to be abided by the College.

Similarly, the College is bound to follow the reservation rules of the Department of Backward Classes and Minority Affairs, Government of West Bengal and the financial rules of the Department of Finance & Audit, Government of West Bengal.

The College is likely to follow the instructions of the West Bengal College Service Commission as the Principal, Teachers and Librarians are recommended by this autonomous institution.

The College is likely to follow the rules and regulations of the Treasury with which it is associated; it is bound to follow the rules and regulations of the Department of Commercial Taxes for making payments of Professional Taxes; it is also bound to follow the rules and regulations of the Department of Income Tax, Government of India for making payments and submitting returns;

It is also bound to follow the orders and instructions given by the civil administrative officers like the District Magistrate, Nadia, Sub-Divisional Officer (Sadar), Block Development Officer, Nakashipara Block.

The College is bound to follow all the directives of the police administration like Superintendent of Police, Deputy Superintendent of Police and the Officer-in-Charge, Nakashipara Police Station.

The College is bound to follow all the orders issued by any Court of Law.
